Memorandum of Understanding Statewide CAD Interface to SHA CHART System

I. INTRODUCTION

This Memorandum of Understanding (MOU) is entered into by and between the Maryland Department of Transportation State Highway Administration (SHA), Maryland State Police (MSP), Maryland Department of Transportation Maryland Transportation Authority (MDTA), Maryland Department of Transportation Maryland Transit Administration (MTA), and the Department of Natural Resources (DNR) (hereinafter collectively referred to as "the Parties").

II. OBJECTIVES

The objective of this MOU is to establish an interface between the Maryland Statewide Computer Aided Dispatch (CAD) system and the SHA Coordinated Highways Action Response Team (CHART) that will allow SHA to retrieve and display non-criminal related CAD incident data on traffic-related codes. There are no costs associated with this MOU.

III. PURPOSE and SCOPE

A. Purpose

The purpose of this MOU is to enhance information sharing and improve upon public safety. Data provided through this MOU will be used by SHA to increase situational awareness by retrieving non-criminal real-time CAD incident data on traffic-related codes into their Advanced Traffic Management System (ATMS) to auto-create Traffic Incidents in the ATMS and speed agency response.

B. Scope

This MOU establishes the Parties' responsibilities related to the transmission of CAD incident data to SHA.

C. Controlling Regulations and Laws

Each Party understands that the provisions of this MOU are subject to the laws and regulations of the United States and the State of Maryland.

D. No Rights Created

This agreement does not, and shall not be construed to create any rights, substantive or procedural, enforceable at law by any person in any matter, civil or criminal.

E. Liability

Each Party is responsible for its own conduct under this MOU, and retains all defenses, including immunities, available under applicable federal, and Maryland State laws. No participant agrees to insure, defend, or indemnify any other.

IV. SHA RESPONSIBILITIES

- A. In consideration for the release of CAD incident data by MSP, MDTA, MTA and DNR to SHA, as shown herein under Figure No. 1, SHA agrees to the following terms and limitations on the use of the information/data as indicated:
 - I. It shall use such information/data only for the purpose for which it has requested such information as indicated in Sections II and III.
 - 2. SHA assumes all responsibility for the proper use, storage, and protection of such information and unauthorized access, modification, dissemination and disclosure.

VII. EFFECTIVE DATE / DURATION / MODIFICATION / TERMINATION

- a. This MOU is effective upon signing by the last Party and shall remain in effect from the latest signature date unless modified or terminated.

- d. The terms and conditions of this MOU constitute the full and complete agreement between the Parties. No other verbal or written agreement shall, in any way, vary or alter any provision of this MOU unless all Parties consent to vary or alter the provision in a signed writing.
