





Validation Cost Clarification

- One line item added to each state's annual budget based on cost
- Additional modules added after the core contract is finalized do not have an additional validation cost added
- Validation contract costs are allocated based on a core data cost at the time of contract renewal or initiation

Data Use Agreements Updates

- All agreements must be submitted online
- We are now using only V10 no pdf's anymore
- Starting January 1, 2023
 - We will start migrating all existing agreements to v10
- Request for all affiliates to be approved by state reps
 - DUA comment affiliates liable for data use not states
- Request from Federal Agencies to be approved by state reps
